#### **East Cheshire Quaker Meeting**

#### **Contributions from local meetings for 2019**

In January 2019 Area Meeting agreed that local meetings be asked to contribute £11,400 to Area Meeting funds in 2019. It is our practice to allocate this contribution figure to local meetings based on their number of active participants. Macclesfield Meeting is not included in this scheme and so they are again asked to contribute what they feel able to. Crewe & Natwich Meeting is now included in the scheme.

In February 2014, Area Meeting agreed that the meetings have a meeting house (currently Cheadle Hulme, Disley, Frandley, Stockport and Wilmslow) be asked to contribute 10% more per active participant than the other meeting Marple which does not have a meeting house and so has to pay rent for its meeting space. The following schedule indicates how the £11,400 would be allocated to local meetings according to this procedure.

### Report to ECAM of MfS 2<sup>nd</sup> February

### **Court and Prison Register**

Friends have been active in supporting the Stanstead activists – including an Attender of Brighton Meeting – found guilty in Chelmsford Crown Court under the 1990 Aviation and Maritime Security Act. (Subsequently they have not been given a custodial sentence).

Post Truth World – Truth and Integrity in the Public Sphere Southern Marches AM had brought a concern to MfS which AMs had been asked to test and consider. We received Minutes from 42 AMs (including ECAM) and many LMs had also considered it.

MfS minute offered that 'Post Truth' may be defined as 'relating to or denoting circumstances in which objective facts are less influential in shaping public opinion than appeals to emotion and personal belief'. We were mindful that Truth and Integrity are central Quaker Testimonies (Advices 37&38) and that Quakers have always had concerns about truth and integrity since the time of George Fox. An 18th century saying 'a lie is half way round the world before Truth has got its boots on' perhaps epitomises this.

So, at MfS we tried to discern - What was new? What should Quakers be doing individually and corporately?

The speed and impact of electronic communication, social media, and its amplification of 'fake news', simplification of argument, encouragement of immediate response, and the present ease of anonymous threats and abuse were new. Also, was there less accountability for deliberate lying by public figures? Was it becoming harder to hold public bodies to account?

MfS reaffirmed the commitment to Truth and Integrity but did not suggest any new committee or programme of work at this time – but encouraged further threshing and networking. Staff are working with other civil society organisations to lobby against laws and regulations which restrict the ability to 'speak Truth to Power'. AMs are encouraged to network with Southern Marches to coordinate information and concerns and consider further our responsibilities and capacities to offer space, learning and support.

# **Yearly Meeting**

We were reminded that now is the time to register for YM. The theme this

year is assumptions of privilege, and how it impacts on our ability to act on the urgent Quaker concerns of climate justice and sustainability, and inclusion and diversity.

### **Book of Discipline Revision Committee**

We approved the nominations for this Committee and were assured the Members were a varied cross-section in terms of skills, age, geography etc.

# Representation on MfS

Arrangements Group thought it appropriate to review the method of representation on MfS which had started in 2012. Currently 70 AMs, 4 Central and Standing Committees, Young Friends General Meeting, Meeting of Friends in Wales, and General Meeting for Scotland nominate one Representative and one Alternate. Arrangements Group proposed just having a nominated Representative with a 'Visitor' attending if the Representative is prevented.

Prior to MfS I discussed this with Andrew Backhouse and we both thought this proposal seriously flawed.

Arrangements Group had thought their proposal would improve continuity at MfS, however this was not accepted at the Meeting. My own discernment was that the change proposed was likely to exacerbate any problems with continuity. The present system means at least 2 people in an AM had papers in advance to discuss them. It is also clear who can go if a person is prevented – perhaps at the last minute. It also means that an AM has continuity of representation if someone asks to be 'laid down' as has recently happened in ECAM.

ECAM may wish to send in comments as MfS Arrangement Committee will be considering the matter further.

#### Quakers in the 1<sup>st</sup> World War

Three AMs had sent minutes on the matter of recording the deaths of 265 Quakers who died in the 1<sup>st</sup> WW, including many who had served in the Military. AA record of names will be created in Friends House Library and any further names to be recorded should be sent to the Recording Clerk. (heleng@guaker.org.uk).

(ECAM Peace Group were previously concerned that no formal Rembrance should be set up, as suggested by Gethin Evans, MfS Representative for Mid Wales AM)

#### Appendix 2 - Relevant organisations

#### **Encouraging Truth and Integrity: what are others doing?**

Truth and integrity are important to all aspects of private and public life, and many civil society groups engage with these issues in different ways. The following examples are grouped under the same headings as those used in the previous paper to Meeting for Sufferings (MfS 2018 04 09). The list is mainly made up of small civil society groups which are likely to welcome the support of individual Quakers, but also includes some statutory, industry and academic groups to help round out the picture.

#### Integrity in the media

#### Voice of the Listener and Viewer 1 (http://www.vlv.org.uk/)

VLV is a small charity that supports plural, high-standards, public service broadcasting, including the independence and integrity of the BBC.

#### Full Fact (<a href="https://fullfact.org/">https://fullfact.org/</a>)

A charity that provides fact-checking of prominent media stories and government statement, along with prime minister's questions, BBC Question Time etc. Also actively involved in encouraging better use of government statistics, and the development of international fact-checking standards and tools. In autumn 2018, Full Fact published a report on tackling misinformation in an open society: <a href="https://fullfact.org/blog/2018/oct/tackling-misinformation-open-society/">https://fullfact.org/blog/2018/oct/tackling-misinformation-open-society/</a>

#### **Stop Funding Hate** (<a href="http://stopfundinghate.info/">http://stopfundinghate.info/</a>)

Founded to challenge media reporting that encourages hatred, particularly in relation to migration and minorities. Works by mobilising the public to put pressure on major retail brands that pay for advertising. This work is not explicitly about media accuracy, though many alarmist or inflammatory articles are also misleading.

### **Community Journalism (various)**

There is a long history of various forms of community media, and this sector is seeing strong growth at present, led by groups such as the Bristol Cable, The Ferret (in Scotland), the Star and Crescent (Portsmouth) and Bradford Community Radio. These groups (and many more) seek to fill some of the gap left by declining local commercial press, and to provide good standard of local journalism. They are often heavily reliant on volunteers and donations.

#### IPSO (https://www.ipso.co.uk/complain/)

The Independent Press Standards Association, the successor to the Press Complaints Commission, is an industry body that considers complaints against its Not to be confused with the National Viewers and Listeners Association, an entirely

different group founded by Mary Whitehouse, and now renamed MediaWatch-UK. 1members, which include many major UK newspapers. IPSO has its critics (see below) but does provide a route for any member of the public to complain about inaccuracy in an article in the press.

#### Impress (https://www.impress.press/ )

Impress is an alternative self-regulator operating in line with the recommendations of Leveson report that followed the phone hacking scandal. Impress' regulated members are largely community media and specialist publishers.

#### Hacked Off (<a href="https://hackinginguiry.org">https://hackinginguiry.org</a>)

Formed in the wake of the phone hacking scandal, Hacked Off campaigns for stronger media regulation (being particularly critical of IPSO) and for more rights for victims of the press.

#### Reuters Institute (https://reutersinstitute.politics.ox.ac.uk/)

There are many academic units that are considering issues of accuracy and misinformation in the media. The Reuters Institute in Oxford is one.

# Personal integrity of those in power Committee on Standards in Public Life

(<u>https://www.gov.uk/government/organisations/the-committee-on-standards-in-public-life</u>

Originally established in the mid-1990s, the Committee has a remit to examine areas of concern about the standards of conduct of public office holders, and to promote the 'Nolan principles' of Selflessness, Integrity, Objectivity, Accountability, Openness and Honesty in public office. Its recent work has included considering how to address intimidation in public life, and reviewing MPs outside interests.

# Institute for Government (https://www.instituteforgovernment.org.uk/)

Amongst other activities, IfG offers professional development to government ministers and shadow ministers. This is primarily focused on effectiveness, rather than moral integrity, but does support a constructive and professional approach to public office.

**Full Fact** (as above). Encourages politicians to use accurate information and to reference the claims that they make.

#### **Constructive engagement with politicians** (various)

While politicians are rightly open to scrutiny and criticism, it is also important that there are opportunities for constructive dialogue between politicians and members of the public.

Groups that foster such engagement include **Involve** (<a href="https://www.involve.org.uk/">https://www.involve.org.uk/</a>) a national charity that promotes participatory democracy,

a small Sheffield charity that promotes constructive engagement on climate change.

#### The Politics Project https://thepoliticsproject.org.uk/

in Manchester and London which

facilitates online conversations between politicians and school pupils.

#### Integrity of our political systems

#### **Transparency International** (<a href="https://www.transparency.org.uk/">https://www.transparency.org.uk/</a>)

An international NGO network, with an active chapter in the UK, promoting integrity and challenging corruption in the private sector, public sector, and the relationship between the two.

#### **Unlock Democracy** (<a href="https://unlockdemocracy.org/">https://unlockdemocracy.org/</a>)

Unlock campaigns for democratic reforms, including a written constitution, reform of party funding rules, and reform of electoral law (to better cover online materials for example). It is the successor body to Charter 88.

#### Electoral Reform Society (<a href="https://www.electoral-reform.org.uk/">https://www.electoral-reform.org.uk/</a>)

The ERS is another group campaigning for democratic reform, particularly for proportional voting systems, but also for House of Lords reform, votes at 16 and other issues. There are ERS groups in all four nations of the UK.

#### **Democracy Club** (<a href="https://democracyclub.org.uk/">https://democracyclub.org.uk/</a>)

A small NGO that mobilises thousands of volunteers to provide data about electoral candidates and results, in order to make it more accessible in an open data format, for other groups and websites to use.

#### Who Targets Me (<a href="https://whotargets.me">https://whotargets.me</a>)

An online tool that allows any Facebook user to see who is targeting them with political advertising.

#### **Democratic Audit** (<a href="http://www.democraticaudit.com/">http://www.democraticaudit.com/</a>)

A group based at the LSE that publishes a regular blog and occasional longer reports on the state of UK democracy. There are many other academic units that research and analyse democracy, including for example the Constitution Unit at UCL.

#### Electoral Commission (https://www.electoralcommission.org.uk/)

This is the statutory body with responsibility for overseeing elections and party finance in the UK.

# What are our current areas of concern about sustainability that we could explore today?

- \*Size of property how to encourage downsizing

Communications with council – what can we recycle? (Walkers Crisp packets can be set back!)

Brexit - food

Greenbelt land – housing? Roads?

We need electrical charging points for electric cars

- \*Packaging
- \*Plastic waste

We exploring some items in smaller groups and some conclusions are below:

#### **Transport**

We need to be more aware of each other's transport needs – to build car sharing for local and area meetings. Could Area Meeting be always held where public transport can reach? Could AM write to Andy Burnham, Mayor of Greater Manchester, to encourage the regulation of buses so that transport at least within Greater Manchester could be more regulated and an Oyster card might work?

#### **Plastic**

This was felt to be better if done by the community working together, raising our voices by writing, talking, and lobbying. Again we could only do this well if we did it in manageable chunks.

#### Sharing

We should do more sharing of food and cook together. We should offer unwanted items around and offer storage to others – "Give to Gain' happens in Stockport apparently. We need to know each others skills and experiences – as for property. And share transport – as above.

#### **Property**

We need to improve meeting houses and homes, have a shared list of experiences that could be beneficial to others, and a pool of useful people/information for the Quaker community. We also have grounds which can be used to improve wildlife.
